2024 - 2025 Tuition Information

Registration for the 2024-2025 school year opens on **February 1, 2024**, for families of returning students and Fishers of Men Lutheran Church members. Registration opens to the public on **February 21, 2024**, for all new students/families.

Placement of children in classes is determined by his/her age as of **September 1, 2024**. **The first day of school is August 27, 2024 and the last day of school is May 16, 2025.** School hours are 9:00 am - 2:00 pm. After-school programs are 2:00 pm - 3:00 pm.

Registration Fees: \$200 for New Students \$175 for Returning Students A 5% Discount is provided if the FULL YEAR's tuition is paid by the first week of school.

2024 - 2025 Tuition Payment Schedule

The **Supply Fee** (non-refundable) must be paid by **May 5, 2024**, and the **May 2025 Tuition Payment** (non-refundable) must be paid by **August 5, 2024**. If the above fees are not paid by their due dates, your child's spot will be released, and all paid fees will be forfeited.

Accounts with insufficient funds will be charged a \$25 NSF penalty fee.

Withdrawal from the preschool program requires a 30-day written notice. If you withdraw your child during the school year, the May 2025 Tuition Payment will NOT be applied to your child's last 30 days.

\bigcirc	I understand that Little Fishers Preschool is open Monday through Friday from 9:00 am to 2:00 pm and Monday through Thursday from 2:00 pm to 3:00 pm for after-school care. If I am late picking up my child after 2:10 pm (3:10 pm if enrolled in after-school care), I will be charged \$5, and \$1 per minute for every minute after that.
\bigcirc	If I choose to withdraw my child from Little Fishers Preschool, I understand that a 30-day notice must be given in writing. I understand that the Registration Fee, Supply Fee, and the May 2025 Tuition Payment WILL NOT be refunded. I also understand that the May 2025 Tuition payment WILL NOT be applied to my child's last 30 days of attendance.
